

ICRI ANNOUNCES NEW PERSONAL AWARDS



**NOMINATIONS FOR ALL AWARDS
ARE DUE MONDAY, SEPTEMBER 3**

To honor those in the concrete repair industry whose service has gone above and beyond the norm, ICRI has created criteria for new personal awards.

HONORARY MEMBERS

The first award, the **ICRI Honorary Member Award**, has already been granted to both Milt and Sally Collins and to Jim Warner. The Fellows Committee has recently put together *new* criteria for this award—somewhat like a lifetime achievement award—which is defined as follows:

An Honorary Member shall be a person of eminence in the field of the Institute's interest, or one who has performed extraordinary meritorious service to the Institute.

DISTINGUISHED SERVICE

The Fellows Committee has also developed criteria for an **ICRI Distinguished Service Award**. This award is based on the fact that ICRI would like to recognize individuals, committees, or “Ad Hoc” Groups who have graciously provided ICRI with a specialized “service above self” contribution to the Institute—either at a National level or locally, at the Chapter level.

The Distinguished Service Award nomination can be submitted by a local chapter or a national committee. The submission will be prepared and signed either by a Chapter President or Committee

Chair and submitted to the Chair of the Fellows Committee with a copy to Creative Association Management (CAM) for review and vote.

The criteria for nomination shall be based on the following:

- The relation of the contribution as it compares to the ICRI Goals and Mission Statement;
- The result and significance of the contribution; and
- Time and effort required to achieve the end result.

FELLOWS

ICRI Headquarters is also currently accepting nominations for **Fellow** of the Institute.

The criteria for nomination shall be based on the following:

- Outstanding contribution to the production or use of concrete repair materials, products, or structures in the areas of education, research, development, design, construction, or management.
- As a prerequisite to election, an individual shall have been an ICRI member for 5 consecutive years.

Nominations for ICRI Fellows may be submitted by any group of five ICRI members, any ICRI Chapter, or the Fellows Committee.
