Another initiative I want to bring to your attention is our effort to get Technical Guideline No. 120.1-2009, "Guidelines and Recommendations for Safety in the Concrete Repair Industry," created by ICRI Committee 120, Environmental Health and Safety, into the hands of those out in the field in our industry. We made the decision to distribute copies to a large number of the contractors on our ICRI mailing list, both to let them experience the Guideline and to give us feedback. To date, we have received several orders from companies that are going to distribute it to their staff for use on site. The manual has been repriced to be attractive to companies and bulk pricing is available for large orders. So, please take a look at the Safety Guideline and see how it will work for you.
